Putting our money to work for us,

From the Princess Banker:

During the recent by-law review process, some important changes affecting our finances were approved by the ladies of the household and subsequently by Supreme Temple.

First, starting January 1, 2014, the Princesses Recorder and Banker will receive stipends rather than salaries. This is possible due to a recent change in IRS rules and updated Supreme by-laws. This means a budget savings for Nydia Temple by not paying payroll taxes on these two salaries. The burden of paying taxes becomes the sole responsibility of the person receiving the stipend and not the organization.

Secondly, for many, many years, the Temple has supported the uniform units by depositing money into accounts strictly to be used for costumes. The amount deposited into the accounts was dependent on the number of members belonging to Nydia Temple. A recent by-law change now directs that allotment be paid directly to the units to be used as they feel most useful. As a result of this change, the three small costume accounts were closed and the money given to each respective unit.

I have completed the transition to the newest QuickBooks program, and our investment account continues to automatically deposit over \$200 each month into our general fund.

Ladies, I wish everyone a Merry Christmas.

SUPREME TEMPLE DAUGHTERS OF THE NILE LEGISLATION RESULTS SUPREME TEMPLE ANNUAL SESSION 2013 – GRAPEVINE, TEXAS

Please be aware of the changes made to the Supreme Temple Daughters of the Nile Bylaws (2010 Revision) by the voting Delegates at the Supreme Temple Ninety-Seventh Annual Supreme Session in Grapevine, Texas. These changes were effective as of the day enacted.

Amendment G-1 to PART 1, ARTICLE II SUPREME TEMPLE, SECTION 1. Membership. This amendment, which would have allowed all registered members of Daughters of the Nile in attendance at Supreme Session to vote, was defeated.

Amendment G-2 to PART I, ARTICLE VI BOARD OF DIRECTORS, SECTION 1. Authority and Duties (b). This amendment, which would have changed the composition of the Board of Directors and instituted a voting process for aspiring Directors, was defeated.

Amendment G-3 to ARTICLES OF INCORPORATION OF SUPREME TEMPLE DAUGHTERS OF THE NILE, ARTICLE IV, 2nd, 3rd and 4th Paragraphs. This amendment, which was dependent on the adoption of Amendment G-2, was withdrawn since Amendment G-2 was defeated.

Amendment G-4 amended PART I, ARTICLE VII SUPREME TEMPLE ELECTIVE OFFICERS, SECTION 5.

Supreme Princess Recorder (a) Supreme Temple Duties 2. and 6. This amendment struck the words "draw checks" and inserted the words "and drawing warrants" in sub-section 2 and inserted the words "Write a warrant to" in sub-section 6. As adopted, they now read:

- Maintain the Supreme Temple General Fund by depositing money in a United States Bank with Federal Deposit Insurance, receiving all bills approved by the Chairman of Finance, and drawing warrants for the payment of such bills.
- Write a warrant to pay Insurance Coverage for the Supreme Temple and each Subordinate Temple from the Supreme Temple General Fund.

Amendment G-5 amended PART I, ARTICLE VII SUPREME TEMPLE ELECTIVE OFFICERS, SECTION 5.

Supreme Princess Recorder (d) Subordinate Temples 6. This amendment struck the words "addresses of" and inserted the words "all contact information for." As adopted, it now reads:

Send, on or before May 1, a list of names of and all contact information for the newly elected Queens and Princesses Recorder to each Board Director and one copy to each Subordinate Temple.

Amendment G-6 amended PART I, ARTICLE VII SUPREME TEMPLE ELECTIVE OFFICERS, SECTION 5.

Supreme Princess Recorder (e) Allocation 1., 2. and 3. This amendment struck the words "gross base salary" and inserted the word "stipend" in sub-section 1. Changes to sub-section 2. were withdrawn. Sub-section 3 was deleted in its entirety. As adopted, it now reads:

- 1. A monthly stipend of one thousand eight hundred dollars (\$1,800.00).
- Two hundred fifty dollars (\$250.00) per month for office rent.



Amendment G-7 amended PART I, ARTICLE VII SUPREME TEMPLE ELECTIVE OFFICERS, SECTION 6.

Supreme Princess Banker (a) Supreme Temple Duties 2. This amendment struck the word "check" and inserted the words "warrant" and added the words "and approved by the Supreme Temple Finance Chairman." As adopted, it now reads:

Disburse money only upon a warrant drawn by the Supreme Princess Recorder and approved by the Supreme Temple Finance Chairman.

Amendment G-8 amended PART I, ARTICLE VII SUPREME TEMPLE ELECTIVE OFFICERS, SECTION 6. Supreme Princess Banker (b) Allocation 1., 2., and 3. This amendment struck the words "gross base salary" and inserted the word "stipend" in sub-section 1. Changes to sub-section 2. were withdrawn. Sub-section 3 was deleted in its entirety. As adopted, it now reads:

- A monthly stipend of one thousand dollars (\$1,000.00).
- 2. Two hundred fifty dollars (\$250.00) per month for office rent.

Amendment G-9 amended PART I, ARTICLE VIII COMMITTEES, SECTION 1. Standing Committees (g). This amendment added a new (g) Financial Review Committee. As adopted, it now reads:

(g) Financial Review Committee shall be composed of one Past Supreme Queen to serve as Chairman and two members of Daughters of the Nile who shall annually review the financial records and processes used in the Offices of the Supreme Princess Recorder and Supreme Princess Banker. The Financial Review Committee shall report its findings to the Delegates at each Annual Session.

Amendment G-10 amended PART II, ARTICLE III OFFICIAL TEMPLE PROPERTIES, SECTION 4. Code of Conduct Booklet (b). This amended added the sentence "The Office of the Princess Recorder is defined to be wherever the Princess Recorder possesses the Temple Seal." As adopted, it now reads:

(b) The copies shall be the property of the Temple and shall be maintained in the Office of the Princess Recorder. The Office of the Princess Recorder is defined to be wherever the Princess Recorder possesses the Temple Seal.

Amendment G-11 amended PART II, ARTICLE X FINANCE, SECTION 1. Annual Per Capita (b). This amendment was amended to add a new sub-section (b). As adopted, it now reads:

- (a) The Annual Per Capita of eight dollars (\$8.00) in the currency of the country for each member in good standing, including Life Members, shall be sent to the Supreme Princess Recorder. The Temple check for the Per Capita and the Annual Reports shall be mailed together and postmarked no later than April 15.
- (b) Annually, the Canadian General Fund shall submit in Canadian currency, a payment percentage amount of the total Supreme Temple Administrative expenses, based on the Supreme Temple audited financial statement of the previous year. The percentage will be calculated on the annual percentage of Canadian members, to total membership in Daughters of the Nile.



Amendment G-12 amended PART I, ARTICLE VII SUPREME TEMPLE ELECTIVE OFFICERS, SECTION 5.

Supreme Princess Recorder (f) Executive Assistants 1. This amendment struck the word "salary" and inserted the word "stipend." As adopted, this now reads:

An Office Assistant to receive a stipend of five hundred dollars (\$500.00) per month.

Amendment G-13 amended PART I, ARTICLE II SUPREME TEMPLE, SECTION 2. Officers (a). This amendment added the words "who shall be the Executive Committee." As adopted, this sub-section now reads:

(a) The Elective Officers of the Supreme Temple shall be Her Supreme Majesty, the Supreme Queen; Supreme Princess Royal; Supreme Princess Tirzah; Supreme Princess Badoura; Supreme Princess Recorder; and Supreme Princess Banker; who shall be the Executive Committee.

Amendment G-14 to PART I, ARTICLE VII SUPREME TEMPLE ELECTIVE OFFICERS, SECTION 1. Supreme Queen (b) Duties. This amendment, which would have prohibited anyone but eligible Past Queens to hold a Supreme Temple appointment, was withdrawn.

Amendment G-15 to PART I, ARTICLE VIII COMMITTEES, First Paragraph. This amendment, which would have prohibited anyone but eligible Past Queens to hold a Supreme Temple appointment, was defeated.

Amendment G-16 to PART I, ARTICLE VIII COMMITTEES, New Second Paragraph. This amendment, which would have prohibited a Past Supreme Queen from serving as Chairman of more than one Supreme Temple Standing or Special Committee, was defeated.

NYDIA TEMPLE NO. 4, DAUGHTERS OF THE NILE Adopted BY-LAW AMENDMENTS November, 2013

ARTICLE IV - EXPENDITURES/ALLOWANCES

Presently Reads:

Section 1. The Princess Recorder shall receive three-hundred-seventy-five dollars (\$375.00) monthly, plus actual cost for telephone, internet access and fifty-dollars (\$50.00) rent.

ARTICLE IV - EXPENDITURES/ALLOWANCES: Adopted to now read:

Section 1. The Princess Recorder shall receive a monthly stipend of four-hundred-twenty-five dollars (\$425.00), plus actual reimbursable expenses in addition to telephone and internet access expenses.

ARTICLE IV - EXPENDITURES/ALLOWANCES

Presently Reads:

Section 2. The Princess Banker may receive fifty dollars (\$50.00) monthly.

ARTICLE IV - EXPENDITURES/ALLOWANCES: Adopted to now read:

Section 2. The Princess Banker may receive a monthly stipend of fifty dollars (\$50.00).

ARTICLE V - TENURE OF OFFICE

Presently Reads:

The Princess Recorder and Princess Banker may be elected to their respective offices, not to exceed five (5) consecutive years. A candidate for the position of Princess Recorder or Princess Banker shall submit to the Princess Recorder a printed resume of qualifications appropriate to the office prior to the date of election.

ARTICLE V - TENURE OF OFFICE: *Adopted to now read:*

The Princess Recorder and Princess Banker shall be elected to their respective offices each year. A candidate for the position of Princess Recorder or Princess Banker shall submit to the Princess Recorder a printed resume of qualifications appropriate to the office prior to the time of annual election.



ARTICLE VI - SUPREME TEMPLE ANNUAL SESSION

Presently Reads:

(b) The Junior Past Queen, Princess Tirzah, Princess Badoura, and two (2) Ladies of the Household, who have been elected delegates to Supreme, shall receive the current registration fee for their attendance at the Supreme Temple Annual Session. If not in attendance, this sum shall be returned immediately to the Temple.

ARTICLE VI - SUPREME TEMPLE ANNUAL SESSION: Adopted to now read:

(b) Princess Tirzah, Princess Badoura, and two (2) Ladies of the Household, who have been elected delegates to Supreme, shall receive the current registration fee for their attendance at the Supreme Temple Annual Session. If not in attendance, this sum shall be returned immediately to the Temple.

ARTICLE VIII - UNIFORMED UNITS

Presently Reads:

Section 1. Twenty-five cents (\$.25) per capita from dues shall be contributed annually to the Nydia Temple Uniformed Units' Costume Funds.

ARTICLE VIII - UNIFORMED UNITS: Adopted to now read:

Section 1. Twenty-five cents (\$.25) per capita from dues shall be contributed annually to the Nydia Temple Uniformed Units equally.
